**Dates:** Friday February 5, Saturday February 6, and Sunday February 7, 2010

**Levels Available:** Beginner Novice and up

**Group Sizes:** Friday, Semi Private Dressage: 2 riders per clinician per hour session  
Saturday (SJ) and Sunday (XC): 4 riders per clinician per 2 hour session or 3 riders per 1.5 hour session as necessitated by clinicians' views for appropriate groupings

**Ride Times:** Friday's flatwork sessions will be posted at [www.nteventing.net](http://www.nteventing.net) by February 1, 2010.

**Format:**

The morning sessions will be preceded with "coffee talk" with the clinicians to lay out the days objectives. Continental breakfast will be provided to riders and auditors. Friday's flatwork sessions will start with more advanced riders to allow less experienced riders to become familiar with the clinicians style of instruction. Once the clinicians have become familiar with the skill sets and levels of experience of the riders, we will have them establish the groupings for the following day and the instructor they will work with (Clayton or Lucinda). We are presenting the Event Clinic in this unique format to allow our membership to best benefit from the talents of our formidable clinicians in small group settings.

**Cost:** (does not include stabling) **NTEA members \$550.00** **NTEA non-members \$625.00**

*Riders who are not members of USEA must pay an additional \$25.00 fee.*

**Auditors** are welcome and highly encouraged. Auditing slots will be limited and are available for prepayment before closing date at a charge of \$25/day or \$50 for all three days for NTEA members, and \$30/day or \$70 for all three days for non-members. All prepaying three day auditors are eligible for the prize drawings which will include fabulous Team Fredericks custom riding wear! After the closing date, there will be no member discount and slots will be available for \$35.00 per day. Participating Riders who are **under the age of 18 must be accompanied by a parent or legal guardian** who will receive a complimentary auditing slot.



**ICP instructors** who have 2 or more students registered to audit, or riding, may attend free of charge. ICP instructors may use their clinic attendance for **ICP Continuing Education Units**.

A deposit of \$250.00 is required at time of submission of application for riding slots. **Clinic riding and auditing slots are guaranteed only with payment in full by the closing date.** If the number of fully completed and paid applications received prior to the closing date should exceed the number of slots available for riding and auditing applications, slots will be filled in the order of marked receipt by post mark or Board Member signature.

**Prior to the closing date,** should you not be able to attend the clinic, NTEA reserves the right to fill the slot from the wait list. If there is no individual on the wait list able to fill the slot, you may sell your spot to another party. A refund of payments rendered minus a \$25.00 administration fee is available **only if written notice is acknowledged and certified as received by the NTEA Board before the closing date,** otherwise there will be no refund.

Additional forms including release of liability waivers and medical information forms and a negative Coggins are required to be submitted by riders prior to the closing date, Auditors also must submit a completed USEA Educational Activity Release.
